

## REQUEST FOR GRANT PROPOSALS:

With this RFP, we seek to identify and fund patient education grants to educate African American patients about CTCL and help address existing racial disparities in diagnosis, treatment and patient outcomes.

#### I. Background

Kyowa Kirin, Inc., an affiliate of Kyowa Kirin Co., Ltd., strives to become a valued and trusted member of patient communities in therapeutic areas aligned with our portfolio, by collaborating with researchers and organizations who are making improvements to patient outcomes with new data, education, and targeted communication / patient empowerment programs.

Kyowa Kirin will employ a general grant program, supported by [a/this] publicly posted general Request for Proposal (RFP) detailing our goals, area(s) of interest, project requirements, and timeline for review, approval and disbursement of grant funds.

Organizations are invited to submit an application addressing the requirements outlined in this RFP. The grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of independent initiatives supported by this grant. Kyowa Kirin will not be involved in any aspect of project management, but may seek to understand and communicate the impact of projects and work supported by its grant(s).

#### II. Unmet Need(s) to be Addressed

Kyowa Kirin is establishing a general grant with the hope it attracts interest from researchers and organizations who have ideas for new research and interventions that can help address the root causes of disparities for African American patients with cutaneous T-cell lymphomas (CTCL) that contribute to poorer outcomes.

 Studies have shown that minority populations, including African-Americans, present symptoms of CTCL at an earlier age, with a more aggressive clinical course<sup>1</sup>

- African-Americans especially have a significantly increased risk of presenting with higher stage of MF when compared to other groups<sup>2</sup>
- Often there is differential and/or potential misdiagnosis of psoriasis, which delays the correct treatment in patients<sup>3</sup>
- There is a need to encourage earlier diagnosis; doing so requires understanding of the reasons behind the racial disparities and effective tactics or programs to help overcome them<sup>2</sup>
- Researchers hypothesize that population density, low awareness, and physician-community relationships are some contributing factors for this disproportion among groups<sup>2</sup>

#### III. Eligibility

Geographic Scope: United States

Type of applicant(s):

The following individuals or organizations who are focused on a mission related to patient education and/or healthcare improvement may apply: Patient advocacy organizations or non-profit foundations; public health/social work/nursing/pharmacy schools or students within these schools; Healthcare institutions (both large and small); and organizations dedicated to African American empowerment and/or health care.

If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all institutions must have a relevant role and the requesting organization must have a key role in the project.

#### IV. Requirements

Project proposals should address knowledge gaps among African American patients and communities about CTCL, including its prevalence and epidemiology, risk factors, diagnosis methods and care pathways.

#### Selected proposals will demonstrate the potential to:

- Address barriers to CTCL disease diagnosis among African American patients;
- Increase awareness among at risk and undiagnosed patient groups before advanced disease has ensued;
- Provide scalable strategies that reduce burdens for patients and providers along the pathway to diagnosis;
- Create strategies that empower and equip African American patients, their families and/or communities to play an active role in exploring CTCL diagnostic and treatment options;
- Build awareness of success stories that further encourage hope among patients.

# Detailed responses to this RFP should contain the following within a 4 page proposal:

- Project name
- Project objectives
  - Clearly define 2-3 goals that will be addressed
- Expected Outputs
  - Please define what deliverables will be produced and when
- Rationale for Project / Outputs to be Created
  - Please describe observed need(s), include any data that clarify the current/existing gaps that will be targeted/addressed
  - Please also explain what measures you have taken to assure the proposed project is original and does not duplicate other projects or materials already developed or in existence.
- Audience
- Evaluation and Outcome Measures
- Scalability
  - If project is successful at achieving its intended goals, please describe how it may be scaled to greater effect



- Organizational Knowledge or Expertise which will be leveraged/ applied to the work
  - Describe, if applicable, how this project builds upon existing work, pilot projects, or on-going projects developed by either your organization or another organization.
- Description / Name of Organization or Team, and professional profiles (e.g. titles, bio) of team members

#### V. Grant Value

- Kyowa Kirin will make \$100,000 available in funds to support these initiatives over a six month period, starting October 1, 2020
- Individual projects requesting up to \$35,000 will be considered
- Kyowa Kirin's support for individual projects may be split into two installments, with an initial payment in 2020 and a final payment in Q1 2021
- A contractual agreement must be signed by all parties awarded a grant, prior to providing grant funding and commencement of the funded project.

This RFP will remain open while funds last. Once the full budget is spent, the RFP will be closed and new requests will no longer be accepted.

#### VI. Timeline

- RFP posting July 13, 2020
- Applications for funds are due by August 20, 2020
- KKNA Grant Review Committee to review proposals submitted by the August 20 deadline by September 8, 2020
  - May result in questions to grantees; All questions must be addressed by September 22, 2020
- Grantees to be notified September 28, 2020
- Public announcements to be made September 30, 2020
- Contract negotiation and execution to be completed October 28, 2020
