Datang International Power Generation Co., Ltd. (the "Company") announces that, according to the Company's preliminary statistics, as of 31 December 2022, the total on-grid power generation of the Company and its subsidiaries amounted to approximately 246.9302 billion kWh, representing a decrease of approximately 4.35% on a year-on-year basis, of which:

The major reasons for the change in on-grid power generation of the Company are:

- 1. Affected by the pandemic, the electricity demand in the areas where the power generation units of the Company are located slowed down, resulting in a year-on-year decrease in on-grid power generation of the Company;
- 2. Considering factors such as the expansion of trading size of the electricity market, the slowdown of electricity demand and the high fuel price, and on the premise of completion of the energy supply guarantee task, the thermal power generation of the Company has decreased year-on-year by optimizing the operation mode and reasonably arranging overhaul and maintenance;
- 3. Affected by the lack of water for hydropower generation, the hydropower generation decreased year-on-year;
- 4. Benefitting from the continuous promotion of the green and low-carbon development by the Company, the installed capacity of wind power and photovoltaic power continued to grow, resulting in a rapidly year-on-year increase in power generation of new energy.

As of 31 December 2022, the average on-grid tariff of the Company was RMB460.79 per MWh (tax inclusive), an increase of approximately 18.37% year-on-year. In 2022, the market-based transaction volume of electricity of the Company was approximately 199.709 billion kWh, accounting for approximately 80.88% of the total.
