Bonavista Energy Corporation Announces Increase to Exchangeable Share Ratio

Calgary – Bonavista Energy Corporation (“Bonavista”) is pleased to announce the increase to the Exchange Ratio of its exchangeable shares from 1.47487 to 1.48526. This increase will be effective on October 15, 2018 (the “Effective Date”).
