# **Suicide Facts & Figures:**

## Utah 2019\*





On average, one person dies by suicide every 13 hours in the state.

Over twelve times as many people died by suicide in Utah in 2017 than in alcohol related motor vehicle accidents.

The total deaths to suicide reflect a total of 16,309 years of potential life lost (YPLL) before age 65.



Suicide cost Utah a total of \$629,958,000 combined lifetime medical and work loss cost in 2010, or an average of \$1,331,835 per suicide death

# Suicide Facts & Figures: Utah 2019

#### **Suicide Prevention Programs and Initiatives**

- The Utah Suicide Prevention Coalition (http://utahsuicideprevention.org/), a public-private partnership, published the Utah Suicide Prevention Plan 2017-2021 (https://bit.ly/2s5sgW8).
- Utah law requires all licensed school district and charter school employees to complete 2 hours of training on youth suicide prevention within their license cycle (§ 53G-9-704); requires the State Board of Education to designate a school suicide prevention coordinator (§53G-9-702); and requires school districts to offer free parent seminars on suicide prevention, among other topics (§ 53G-9-703).
- Utah law (§ 62A-15-1101) requires the Division of Substance Abuse and Mental Health (DSAMH) to designate a state suicide prevention coordinator.
- Utah law (§§ 53E-10-501 to 504) establishes a 24/7 School Safety and Crisis Line within the University Neuropsychiatric Institute and creates the School Safety and Crisis Line Commission.
- HB 41 (adopted 3/22/18) directs DSMAH to establish a 24/7/365 Statewide Mental Health
  Crisis Line with a short code for texting and N11 number for calls and requires local mental
  health authorities and DSMAH to ensure calls are answered without wait times by a mental
  health therapist or trained crisis worker. HB 42 (adopted 3/22/18) seeks to include crisis lines
  as well as mobile crisis outreach teams in the state Medicaid plan.
- Utah law requires at least 2 hours of training in suicide prevention as a condition of licensure for recreational therapists (§ 58-40-302), social workers (§ 58-60-302), marriage and family therapists (§ 58-60-305), clinical mental health counselors (§ 58-60-405), and substance use disorder counselors (§ 58-60-506).
- HB 370 (adopted 3/22/18), among other provisions, expands the scope of youth suicide prevention programs in schools and amends existing provisions regarding medical examiner records to aid in suicide research efforts.
