Inter Pipeline Announces June 2019 Cash Dividend

CALGARY, ALBERTA, June 10, 2019: Inter Pipeline Ltd. ("Inter Pipeline") (TSX:IPL) announced today the declaration of a cash dividend of \$0.1425 per share for June 2019. This dividend will be paid on or about July 15, 2019 to shareholders of record on June 21, 2019. This dividend is designated as an "eligible dividend" for Canadian tax purposes.

Since inception, Inter Pipeline has distributed approximately \$5.4 billion in cash payments to investors. Inter Pipeline's objective is to provide investors with sustainable monthly cash dividends, with dividend growth upside tied to the development of Inter Pipeline's portfolio of growth projects.

Inter Pipeline is a major petroleum transportation, natural gas liquids processing, and bulk liquid storage business based in Calgary, Alberta, Canada. Inter Pipeline owns and operates energy infrastructure assets in western Canada and Europe.
